The Southwestern Community College District (District) proposes entering into a side letter agreement with the Southwestern College Education Association (SCEA) regarding District Policy No. 5025, Part-time Faculty Assignments, in order to clarify the issue of "retroactivity" as it pertains to the vesting of adjunct faculty. "Retroactivity" applies to those adjunct faculty in good standing, who have taught more than 18 Lecture Hour Equivalent (LHE) over three consecutive semesters in one discipline with satisfactory performance.

- It is agreed that during this Pilot Program all adjunct faculty who meet the criteria stated above are immediately vested.
- It is further agreed that the Pilot Program will be continued subject to mutual agreement between the District and the SCEA regarding adjunct faculty evaluation/vesting processes/procedures. It is also agreed that a good-faith effort will be made by all parties to ensure that the evaluation process be developed and implemented prior to Fall Semester, 2005, in order for the Program to be eligible for continuance.
