FEDERAL PELL GRANT

The Pell Grant awards are split into two disbursements per semester. The initial semester disbursement will be 30% of your semester eligibility. The second disbursement will be the remainder of your semester eligibility (excluding short sessions beginning mid-term, which will be included in your enrollment calculation the following scheduled disbursement). Pell Grant awards displayed on your award letter represent your full-time eligibility; students enrolled in less than full-time enrollment will receive a <u>PRORATED</u> Pell award. <u>Disbursement dates are assigned based on the date of your initial Pell award cutoff date for each scheduled disbursement date is indicated below. Once an initial Pell award cutoff date has passed, your disbursement will be scheduled for the next available disbursement date.</u>
