Sleep Train Amphitheatre will be waiving their rental fee as part of their community service; however, we will have associated costs for the use of the facility totaling \$13,550, which will include the use of restroom facilities, parking, custodial, audio system, and other services related to the use of the facility. This agreement will secure LN, otherwise known as Sleep Train Amphitheatre, as the venue for the annual commencement ceremony on May 29, 2013. Normally, the ceremony is held on the last day of the spring semester; however, this year's ceremony will be held the week after final examinations are concluded due to availability of Sleep Train Amphitheatre. Other dates provided were in conflict with final examinations and would have impacted student, faculty, and staff participation in the ceremony.

## **OVERVIEW**

Fiscal Impact

Program and project actions are required to maintain adequate coordination and communication on a number of projects in various stages (punch list/close out, mobilization/start up).

Active construction contracts on campus will require additional construction management services. Mr. DePew is the senior project manager of the Gensler and RBF design contracts for the Field House/Central Plant/Athletic Fields and Front Entranceway Landscape project. (Gotham and Elmhurst). Extension of this service is needed to provide adequate construction contract management staff for the new and existing projects underway.

It is anticipated that we may need Mr. DePew's services for approximately fourteen months at 168 hours per month. This is how the additional fee of \$192,864 was calculated  $$82/hour \times 168 hours/month \times 14 months$ ).

The original agreement with Mr. DePew, approved by the Governing Board on January 26, 2012, was for a total amount not to exceed \$23,460. Amendment No. 1 to Mr. DePew's original agreement approved by the Governing Board on March 14, 2012 stated a not to exceed total amount of \$121,116. Amendment No. 2 was approved by the Governing Board on August 8, 2012 for a new total amount not to exceed \$212,956.
