This item only concerns bidders on Bid 194 Trade Package 4 and 4A.

In awarding Trade Packages 4 and 4A Southwestern College will follow Public Contract Code 20103.8 paragraph (b), in determining how to assess the lowest bid.

This process means that: The lowest bidder shall be determined by the lowest total bid of both the bid prices of the Base Bid: Trade Package 4 plus the allowance for Trade Package 4, AND the Additive Alternate No 1. Trade Package 4A plus the allowance for Trade Package 4A.

1. Document 00300 Bid Form Addendum 7, Revision 3, June 8, 2012 should be used to submit the bids. Note page 2 has been revised to reflect how the District will add Bid Packages 4 and 4A and both Bid Packages allowances to determine the low bidder.

- 3. In consideration of this addendum bidders on Trade Packages 4 and 4A may submit a single bid bond covering their combined bid amount on the Base Bid plus Allowance and ALTERNATE No. 1 plus allowance.
